**REGULAR MEETING
MINUTES
Thursday, March 20, 2014
6:00 p.m.**

1. ESTABLISH QUORUM AND CALL TO ORDER

President Enns called the meeting to order at 6:00p.m.

Board members present: President Robert Enns, Vice-President Dan Chivens, Director Michael Foster and Director Dan Lloyd. Director Shirley Lyon was absent.

Staff present: District Manager Rick Koon and Admin Services Accounting Manager Anita Rebich

2. PUBLIC COMMENTS

President Enns opened the meeting to Public Comments.

Hearing none, Public Comments was closed.

3. DISCUSSION AND CONSIDERATION TO AUTHORIZE THE DISTRICT MANAGER TO SOLICIT BIDS, AWARD AND EXECUTE A CONTRACT FOR REPAIRS TO THE DISTRICT SEWER MAINS IN FIVE (5) LOCATIONS

Manager Koon reported on the five (5) locations that are in need of repair and showed actual video of the inside of the pipe at each location. Koon attributed these finds to the O&M crew and their new camera. It was reported that three (3) contractors have expressed an interest in bidding the project. President Enns asked why there were 5 projects on the bid sheet. Koon replied that he wants to see bids for each location but didn't want to have multiple contractors performing the work. He envisioned them starting the project at a particular location, completing that then moving to the next and so on until all five locations are complete. Director Foster was delighted that we are paying attention to the rules of the UPCCAA but went on to state that some of these repairs may have even fallen under emergency repairs and not required this. He was pleased that we did it this way.

MOTION: 1st by Chivens, 2nd by Lloyd to Authorize the District Manager to Solicit Bids, Award and Execute a Contract for Repairs to the District Sewer Mains in Five (5) Locations.

A. Manager Koon's report was accepted as presented. Koon confirmed the meeting for tomorrow at 10:00am at the RWQCB in San Luis Obispo. Koon also reported that WSC has begun the design work on the Main Street sewer replacement and should have a draft study available in about 2 weeks.


